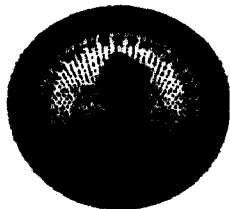

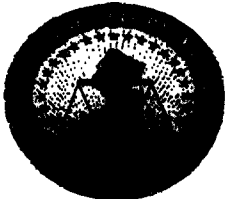
Please be advised that Governor Corzine has directed Treasurer Abelow to review how the Property Tax Assistance and Community Development Block Grants program (the "Program") has been implemented and that, while this review is under way, no further action will be taken regarding distribution of grants under this Program.

Currently, \$26,766,781.19 remains in the Program account from the fiscal year 2005 and 2006 appropriations. Please be advised that the Department of Treasury has agreed to place all of these funds in a reserve account until such time as the review the Governor has ordered has been completed.
